VOLUNTARY POST-OFFER INIVITATION TO SELF-IDENTIFY AS A PROTECTED VETERAN

Rutgers, The State University of New Jersey is a federal contractor subject to the Vietnam Era Veterans' Readjustment Assistance Act of 1974, as amended by the Jobs for Veterans Act of 2002, 38 U.S.C. 4214 ("VEVRAA"), which requires contractors to take affirmative action to employ and advance in employment disabled veterans, recently separated veterans, active duty wartime or campaign badge veterans, and Armed Forces service medal veterans.

If you believe you belong to any of the categories of protected veterans listed above, please indicate by checking the appropriate box(es) below. As a government contractor subject to VEVRAA, we request this information in order to measure the effectiveness and the outreach and positive recruitment efforts we undertake pursuant to VEVRAA. A "disabled veteran" is one of the following: (a) a veteran of the U.S. military, ground, naval or air service who is entitled to compensatio (or who but for the receipt of military retired pay would be entitled to compensation) under laws administered by the Secretary of Veterar Affairs; or (b) a person who is discharged or released from active duty because of a service-connected disability.
RECENTLY SEPARATED VETERAN
A "recently separated" veteran means any veteran was discharged or released from active duty in the U.S. military, ground, naval or a service within the last three years.
ACTIVE DUTY WARTIME OR CAMPAIGN BADGE VETERAN
An "active duty wartime or campaign badge veteran" means a veteran who served on active duty in the U.S. military ground, naval or a service during a war, or in a campaign or expedition for which a campaign badge has been authorized under the laws administered by the Department of Defense.
ARMED FORCES SERVICE MEDAL VETERAN
An "Armed Forces service medal veteran" means a veteran who, while serving on active duty in the U.S. military, ground, naval or a service, participated in a United States military operation for which an Armed Forces service medal was awarded pursuant to Executive Order 12985.
